Docket Sheet Report

The Docket Sheet Report displays a cover page and docket entries for a single case.

In criminal cases with multiple defendants, the docket sheet format is different when defendants are selected individually than when all defendants are selected.

- For defendants selected individually, a docket sheet is produced for each defendant with a heading, caption and proceedings, but the proceedings include only the events that apply to that defendant.
- If the *All defendants* checkbox is checked, one docket report is produced with a single heading, a caption area for each defendant, and all the proceedings are included.

From the Main Menu: **Reports** rightarrow **Docket Sheet.**

STEP 1 CM/ECF will display the **Docket Sheet Report** selection screen.

• The number of the last case accessed will be displayed in the Case number field. If the correct case number is displayed, go to Step 3. Otherwise, continue to Step 2 below.

STEP 2 Click inside the Case number field and begin entering the case number.While entering the case number, the [Find This Case] button displays. Click [Find This Case] to locate the case, which also re-formats the case number.

STEP 3 Selecting the Search Criteria. After the case number is located, the Docket Sheet Report selection screen re-displays. Prior to running the report, examine the various options as possible search criteria.

Filed or Entered. It is not required to select either the Filed (dated filed with the court) or Entered radio button (date entries were made in CM/ECF). Entering the start and end dates is particularly beneficial when narrowing your search in larger cases and when seeking to reduce PACER charges.

Documents. Similarly, in an effort to narrow your search, you may enter a specific from/to range of document numbers.

- If a document number range is specified, docket entries that do not have number are <u>not</u> listed.
- If no document number range is entered, all events are listed whether or not they have numbers.

Include. Select or deselect by clicking in the checkmark box by any of the items to be included in the docket sheet report.

- Parties and counsel
 Includes the complete caption page
- Terminated parties.
 Will include parties who are no longer active in the case
- List of member cases in consolidated matters.
 - If *unchecked*, the *Lead Docket* label and case number hyperlink appear on the docket sheet, along with a second <u>View Member Cases</u> hyperlink, providing links to the member cases.
 - If *checked*, the lead case number hyperlink appears with a list of member cases under a *Member Cases* label on the docket sheet. Each member case would be listed as a hyperlink to its docket sheet.
- **Links to Notices of Electronic Filing.** The NEF links appear as silver balls adjacent to each docket entry.

- **HTML.** Will create a docket sheet viewable on the screen without page breaks one continuous docket sheet.
- **PDF**. Will create a printable docket sheet with clean breaks between docket entries at the end of a page.

- **View Selected** By clicking the **[View Selected]** button, ECF will compile all the selected documents into one PDF document.
- **Download Selected** By clicking the **[Download Selected]** button, the message, **"Your download will begin in a separate window**" will display, resulting in the display of the **File Download** dialog box.



- **[Open]** button. Opens another folder to reveal the separate documents you had selected. You still need to save them to a location on your computer/network.
- **[Save]** button. Allows the user to navigate to the drive/folder location to save the documents. The documents will be saved separately in a .zip file.
