**AMENDED GENERAL ORDER NO.
405 ADDING ACOUSTIC RESEARCH
DETACHMENT (ARD) BAYVIEW**

This matter having come before the Court on motion of the United States of America to adopt a proposed collateral forfeiture schedule for misdemeanor and petty offenses committed within Acoustic Research Detachment Bayview, a subordinate unit of United States Naval Station Everett (ARD Bayview). General Order 405 contains the collective collateral forfeiture schedule for misdemeanor and petty offenses committed within the purview of federal agencies in the District of Idaho – known as the Central Violations Bureau (CVB) Collateral Forfeiture Schedule – but heretofore did not include ARD Bayview. Accordingly, the Court will amend General Order 405 to include ARD Bayview.

IT IS HEREBY ORDERED that General Order No 405 is amended to include the collateral forfeiture schedule for misdemeanor and petty offenses committed within the ADR Bayview. The August 2024 Collateral Forfeiture Schedule is attached.

This Amended General Order supersedes all collateral forfeiture schedules heretofore adopted. DATED this 13th day of August 2024.

Unless otherwise specifically ordered by a United States Court, any fish, wildlife, or property, which has been seized under authority of the following statutes:

Endangered Species Act, 16 USC §§ 1531-1544; Marine Mammal Protection Act, 16 USC §§ 1371-1389; Lacey Act Amendments of 1981, 16 USC §§ 3371-3378;

where final disposition of the case has been made, by either payment of a forfeiture of collateral or a judgment by the Court, on behalf of the government and where so authorized by statute, such fish and wildlife or property shall be forfeited to the U.S. Government. The property will be disposed of by the National Marine Fisheries Service in the manner proscribed by Title 15, Code of Federal Regulations, Part 904.
